AN ORDINANCE

Amending the General Fund – Department of Public Works Budget to change the title of one (1) Chief Maintenance Supervisor (13N) to Traffic Control Specialist (13N). The step/pay grade will not be affected by this change.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the General Fund – Department of Public Works Budget be amended by changing one (1) Chief Maintenance Supervisor (13N) to Traffic Control Specialist (13N)

SECTION TWO: That this Ordinance will take effect ten (10) days after final passage.

SECTION THREE: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

- What department or bureau is this bill originating from? Where did the initiative for the bill originate?

Public Works – Traffic Bureau

- Summary and facts of the bill.

This bill is to change the title of the Chief Maintenance Supervisor to a Traffic Control Specialist in the Department of Public Works, Traffic Bureau. This is a title change only and will remain a non-bargaining position, pay grade 13. There is no financial impact in this change.

This position is currently vacant after 15 years and are confident this position would be better titled as a Traffic Control Specialist because they provide technical support for the Traffic Control Superintendent. This title change would also assist with recruiting a qualified candidate and be more in line with the job responsibilities such as collect, analyze, and develop reports and recommendations with respect to pedestrian and vehicle safety, flow and control of traffic and design, placement, and operations of the traffic signal system.

The purpose of this bill is to do a title change from a Chief Maintenance Supervisor to a Traffic Control Specialist in the Traffic Bureau.
