I received notice from HR that your last day with the City was today, 02/27/2023. All contributions made to the Police Pension Fund are eligible to be returned to you (these were made via payroll gross wage deductions).

To start the refund process, please send me a request in writing (email is fine) including:

1. Written request for refund of pension contributions (can be a letter attached to an email or just the body of the email itself is acceptable)
2. Your name, phone # and email address
3. The mailing address where you would like the check mailed to (refunds are paid via lump sum paper check)

Once I have an official request for the file and *after* your final paycheck posts, I will forward the file to the Pension Board for their approval.

Upon approval by the board, I will update you to let you know to keep an eye on the mail.
