AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a transfer in the amount of Four Hundred Twenty Thousand (\$420,000.00) Dollars from the Trexler Fund to the Jordan Skatepark and WPA Structures capital projects accounts. These funds will be used for Phase 2 of the Skatepark in Jordan Park, project manuals for the repairs to Lehigh Parkway Phase 4 and repairs at Union Terrace Park.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer in the amount of Four Hundred Twenty Thousand (\$420,000.00) Dollars from the Trexler Fund to the Jordan Skatepark and WPA Structures capital projects accounts in the following manner:

Department of Parks and Recreation

- **Summary and Facts of the Bill**

Transfer funds from the Trexler operating budget to the Jordan Skatepark and WPA Structures capital projects. A total of \$400,000.00 needs to be transferred into the Jordan Skatepark Capital account to construct Phase 2 of the Skatepark in Jordan Park and a total of \$20,000.00 needs to be transferred to the WPA Structures Capital account to create project manuals for the repairs to Lehigh Parkway Phase 4 and repairs at Union Terrace Park. This is part of the 2023-24 Trexler Capital Project allocation.

- **Purpose – Please include the following in your explanation:**

- **What does the Bill do – what are the specific goals/tasks the bill seek to accomplish**

Transfer \$420,000.00 from the Trexler operating budget into Jordan Skatepark and WPA Structures capital project accounts. These funds will be used to construct Phase 2 of the Skatepark and used to create project manuals for the WPA Structures repairs.

- **What are the Benefits of doing this/Down-side of doing this**

Transferring these funds will allow for the construct Phase 2 of the Skatepark to finish the park for the community to enjoy. Also to repair the WPA Structures from further decline.

- **How does this Bill related to the City's Vision/Mission/Priorities**

Transferring these funds allows the Parks Department to construct Phase 2 of the Skatepark and to create repair manuals for the WPA Structures. This completes the whole Skatepark project and this preserves the WPA structures within the City parks.
