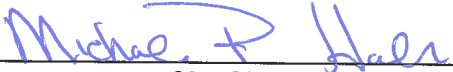
WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

1. Name of Contractor/Consultant: TD Bank, N.A.
2. Project or Contract Reference: RFP No. 2023-19 Financial Services Cost Evaluation
3. Description of Service(s): Provide state of the art banking and cash management services for all of its funds not restricted by law or bond covenants. The City needs a full-service banking institution that has the capacity and ability to provide all of the City's banking requirements. In addition, this request would also select a qualified firm to provide an automated accounts payable solution to the City to pay its vendors and/or suppliers and purchasing card/credit card services.

- Description of project or scope of services to be provided:

On April 12, 2023, the City advertised a solicitation to secure the services of a qualified financial institution to provide state of the art banking and cash management services for all of its funds not restricted by law or bond covenants. The City needs a full-service banking institution that has the capacity and ability to provide all the City's banking requirements. In addition, this request would also select a qualified firm to provide an automated accounts payable solution to the City to pay its vendors and/or suppliers and purchasing card/credit card services. On May 10, 2023, the public meeting held for which the City received four (4) proposals; however, one (1) proposal was rejected. Three (3) proposals were distributed to all committee members via Teams for evaluation.

The technical evaluation was held on May 17, 2023. All committee members were present in person and via Teams. The Proposals were scored based on the RFP requirements, IBE Preference (10 Points), Banking Services and Products (45 Points), Treasury Staff Access and Ease Ability (20 Points), Customer Service Support (10 Points), and Implementation Plan (5 Points). Cost proposals were opened on May 17, 2023. Proposals were distributed to all committee members via Teams for evaluation after the completion of the technical evaluation. The cost evaluation committee meeting occurred on May 22, 2023. All scoring committee members were present in person and via Teams. The committee members discussed the Cost proposal (20 Points). The evaluation committee has decided to not hold oral interviews for this project. They have decided based on the Technical and Cost Proposal scores. The committee decided to award based on qualifications and overall score. The committee is recommending award to TD Bank.

- Contract Term:

The Contract term shall commence upon full execution and shall cease three (3) years thereafter.

Upon written agreement, this contract may be extended for up to two (2) additional one (1) year terms beyond the contract expiration period.
