AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a transfer of One Million One Hundred and Fifty Thousand (\$1,150,000.00) Dollars from the unappropriated balance to the Hanover Ave Traffic Signal Improvements capital account. These funds were awarded as a MTF-DCED grant to install a traffic adaptive system on Hanover Avenue from Albert Street to Wahneta Street. This grant also includes installing a new Rectangular Rapid Flashing Beacon (RRFB) at Hanover Avenue and Linden Street.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes a transfer in the amount One Million One Hundred and Fifty Thousand (\$1,150,000.00) Dollars from the unappropriated balance to the capital account below:

Public Works – Traffic Planning and Control

- Summary and facts of the bill.

The City was awarded a MTF-DCED grant in the amount of \$1,150,000. As part of the grant requirements, the City needed to provide a \$110,000 match. The match funds have been secured; however, the grant funds of \$1,150,000 need to be transferred into the capital account so the work can be done. Since this is a reimbursable grant, the funds will be reimbursed to the general fund capital fund account (001-7144) when the project is completed. The total estimated project cost will be \$1,260,000.

This grant is to install a traffic adaptive system on Hanover Avenue from Albert Street to Wahneta Street. This grant also includes installing a new Rectangular Rapid Flashing Beacon (RRFB) at Hanover Avenue and Linden Street.

This bill is to transfer funds from the unappropriated balance to the capital account Hanover Ave Traffic Signal Improvements (2037)
